What's new?

With respect to the previous release (J1.136+), this one includes the following updates/changes:

POLICIES AND FUNTIONALITIES

- Updated **2025 policy systems** for all countries
- Updated **uprating factors** across multiple variables, including employment income using Eurostat hourly wages by sector of activity
- Updated **external statistics** table, including distributional statistics and consumption tax revenues
- Updated **consumption taxes table** with HICP data from Eurostat
- New calculation of **expenditure variables xed00 and xhl00**, based on the information on consumption available in the input data
- Floating **policy parameters for Family Benefits, Personal Income Tax and Social Insurance Contributions saved as constants** for Austria, Belgium, Czechia, Denmark, Estonia, Greece, France, Croatia, Ireland, Luxembourg, Netherlands, Portugal, Romania, Slovenia and Slovakia.
- **Bug fixes and improvements** across all country models.
